Your 2024–2025 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you and your spouse (if married) reported on your FAFSA. To verify that you provided correct information the financial aid administrator at your school will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid administrator at your school. Your school may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed.

Important Note: The instructions below apply to the student and spouse, if the student is married. Notify the financial aid office if the student or spouse filed separate IRS income tax returns for 2022 or had a change in marital status after the end of the 2022 tax year on December 31, 2022

Instructions: Complete this section if the student and spouse filed or will file a 2022 IRS income tax return(s). The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at FAFSA.gov. In most cases, no further documentation is needed to verify 2022 income information that was transferred into the student's FAFSA using the IRS DRT if that information was not changed.

In most cases, for electronic tax return filers, 2022 IRS income tax return information for the IRS DRT is available within 2–3 weeks after the 2022 electronic IRS income tax return has been accepted by the IRS. Generally, for filers of 2022 paper IRS income tax returns, the 2022 IRS income tax return information is available for the IRS DRT within 8–11 weeks after the 2022 paper IRS income tax return has been received by the IRS. Use the Social Security Number (or the IRS individual taxpayer identification number) and the date of birth of the first person listed on the 2022 IRS income tax return, and the address on file with the IRS (normally this will be the address used on the 2022 IRS income tax return). In most cases, for electronic filers, a 2022 IRS Tax Return Transcript may be requested from the IRS within 2–3 weeks after the 2022 IRS income tax return has been accepted by the IRS. Generally, for filers of 2022 paper IRS income tax returns, the 2022 IRS Tax Return Transcript may be requested within 8–11 weeks after the 2022 paper IRS income tax return has been received by the IRS.

If the student and spouse filed separate 2022 IRS income tax returns, 2022 IRS Tax Return Transcripts must be provided for both.
